## Health and Safety Policy Statement

It is the Organisation's declared policy to carry out all measures reasonably practicable to facilitate the ability to continually improve Health & Safety performance via practical determination of H&S objectives. Where relevant and practical DLS will consult and involve employees and interested parties as to take into account their input within DLS Integrated Management System (IMS).

The company is committed to eliminate hazards and reduce Occupational Health and Safety risks as far as is reasonably practical. To assist in this the Company shall endeavour to:

1. Assess and re-assess as needs be all risk assessments associated with DLS activities with the assistance of shop floor staff with a view to eliminate or reduce the level of hazards identified.
2. Ensure that all contractor / sub-contractor operations are in-line with this policy, and that they are aware of their respective responsibilities and need to supply documentation to this effect.
3. Train all employees and where applicable Agency workers and Contractors in H&S requirements and as applicable Customer's site rules.
4. All work shall be carried out to the required safety standards of the business, clients and statutory legal requirements to eliminate or help minimise the number of incidents.
5. Ensure all work equipment is fit for purpose and is compliant with legislation requirements and provide suitable and sufficient information and instructions for its safe use.
6. Ensure the provision and use of prescribed Personal Protective Equipment (PPE) as applicable.
7. All pertinent safety related information is communicated to all stakeholders where required.
8. Minimise risk to the general public and visitors from the Company's operations and activities.
9. That this policy is communicated to all employees, suppliers and contractors and as may be required is made available to interested parties the public upon request..

All personnel should understand their obligations under this policy statement, and abide with the principals and contents of H&S requirements within the Company's Integrated Management System.

The Organisation regularly monitors and reviews its H&S performance and this Policy Statement to ensure its continuing suitability, and shall implement improvements when and as appropriate.
